

The criminal legal system impacts many of us.

2 million people

6 million people

5 million people

100 million people

living in prison or jail in the U.S.

living under correctional control

who are formerly incarcerated

with a criminal record

1 in 2 adults in the U.S. have an immediate family member that has been incarcerated.

1 in 4 adults have a criminal record in the U.S.

Many supportive housing tenants in NY have been impacted by the carceral system

- In September 2022, the average daily number of individuals incarcerated in NYS was almost 16K
- New York prisons release about 20,790 people every year
- NYS has an incarceration rate of 376 per 100K people

What city do you think has the highest people to prison per capita?

- Upstate counties send more people to prison per capita:
 - Rochester <u>1,051 per 100K</u>
 - Albany 917 per 100K
 - Syracuse 864 per 100K
 - NYC 185 per 100K

Disproportionate impacts: people with low-incomes

Low-income adults are more likely to be arrested and more likely to be charged with crimes that carry longer sentences than adults with higher incomes.

Adults in poverty are 3x more likely to be arrested


People earning <150% federal poverty level are 15x more likely to be charged with a felony

Disproportionate impacts: communities of color

BIPOC are overrepresented in our prisons and jails and are more likely to be policed and arrested, compared to a white person.

This is driven by discriminatory policies and discretionary processes.

- Who gets arrested
- How bail is set
- Who gets what sentence
- Who is granted parole



Note: Native people (who are not represented on this chart) are also overrepresented in the criminal legal system, facing an incarceration rate nearly double that of white Americans.






Homeless

Jail vs. Supportive Housing



Total yearly cost of 2,589 people on Rikers Island who need supportive housing:

\$1.4 Billion



Total yearly cost of 2,589 people in supportive housing:


\$108 Million

IMPACT:

Housing the estimated 2,589 people incarcerated on Rikers Island in a given year that need supportive housing would cost NYC \$1.2B less than incarcerating the same number of people in one year.



OVERVIEW OF SUPPORTIVE SERVICES



Providence House Women's Justice Program A Brief Overview

Over 30 years of providing transitional housing for single women and families who have current or recent justice involvement

Transitional Program:

- 1. Resident have own room but share kitchen, living room and
 - dining room. Bathrooms are private but shared.
- 2.Two residents share an apartment unit, shared space and
 - services on first floor.
- 3. Residents come directly from Rikers or Prison and can stay up
 - to 18 months

Permanent Supportive Housing:

- 1. Studio apartments.
- 2. Mixed tenant building.
- 3. Four buildings. Largest 44 units.

In 2022 Providence House served 60 women whose lives were touched by the legal system

Demographic

- 23% were mothers
- 98% had significant mental health issues
- 47% Had substance use history
- 10% over 50
- 40% under 30
- 14%Identified as LGBTQ
- 5% had significant health issues

Service issue

- Family reunification/complicated grief/ attachment
- Assessment/medication/referral/ counseling/support
- Harm reduction
- Aging issues
- Adolescent issues
- Documents/ Harassment/Identity
- Medical Services

For Everyone

- Trauma informed practice-staff and environment
- Acclimate to current social environment if have been away a long time
- Safety plan
- Self- care plan
- Monitoring functionality
- Staff as mentors, role models, listening ears
- Building a community
- Creative Arts Therapy

Services-Light Touch

- Assist in getting Identity documents
- Assist in getting HRA activated
- Help make a connection to PCP
- Explore and encourage community connections
- Referral to recovery groups if desired for those in recovery
- Ensure court mandates are met
- Explore what to do in free time
- Assist developing cooking, independent living skills
- Work on financial literacy
- Employment determine interests / training or work
- Psychoeducation emotion management, relationships, communication, substitutions for risk taking behavior
- Provide Nutrition/wellness education
- Assist in reestablishing family supports/reunification

Services - Intensive

- Mental health assessment including depression/ suicidality
- Connection to mental health provider if indicated
- Onsite Licensed Psychiatric Nurse Practioner onsite: Medication management, monitor functioning, differential diagnosis
- Coordination with Psychiatrist, therapist
- Referral to Substance use programming
- Referral to substance use treatment/rehab if needed
- Harm reduction
- Wellness checks
- Medical /psych support for gender transitioning

Key Services for Formerly Incarcerated

Resolution of court case

Establish positive community connections

 Acknowledgment of trauma, mindfulness of triggers, develop emotion management skill

Establish financial stability

Assist with housing search and process – independent or supportive

Training for Staff

- Trauma Informed Practice
- Crisis prevention & de-escalation
- Mental Health First Aid
- Cultural Competency and Cultural Humility
- Understanding the needs of the LGBTQ community (eg. intake- ask name preferences)
- Harm reduction/Narcan
- CPR
- Motivational Interviewing
- Crisis intervention- EMS/EDP
- Person centered practice
- DBT

Moving to Supportive or Independent Community Housing

Supportive Housing

Living with significant mental illness that interferes with maintaining independent stability.

Independent Living in the Community

- Can maintain stable income
- Can manage medication & mental/medical health independently

Permanent Housing Barriers for this Population

- Transitional housing does not qualify for city vouchers
- Housing options for residents that have trauma histories & experiences that they are working to overcome don't always come through in a psychiatric evaluation
- Housing for residents who have substance use histories is limited unless there is also an SMI diagnosis
- Time in prison/jail does not count as homelessness for most supportive housing
- Misunderstanding on the part of the resident regarding the level of intrusiveness of supportive housing
- Charge can be a barrier to being accepted
- Affordable housing options not available or have long process

Marcus Garvey Supportive Housing

Located at: 461 Chester Street, Brooklyn, NY 11212

52 studio and one-bedroom units available for people re-entering the community after incarceration.

> On site services provided by the Osborne Association.



Implementation Phase

Marcus Garvey provides permanent, supportive housing with on-site case management and group programming to persons over 50 returning from long term incarceration, unstably housed or homeless.

We are creating a safe, supportive community for returning people to call home.

- Our first resident moved in on June 27,2022
- All 52 Residents have moved in.
- We have a waiting list of over 150 applicants






The U.S. Prison Population is Aging

People 50+ are the **fastest** growing demographic in prison.


By 2030, 1/3 of all incarcerated people will be older, a 4400% increase over 50 years.



- ENSURE LONG TERM SUSTAINABILITY BY CREATING A
 NETWORK OF SUPPORT FOR YOU CLIENT TO STAY IN PLACE

Opportunities for Future Engagement
