

# CALL TO ACTION TOOLKIT

Cap & Trade Negotiations and AHSC Funding

**Context**: The Governor's recently released May Revise Budget Proposal included a proposal for Cap and Trade extension - <u>but it does not commit to maintaining a continuous appropriation for the</u> **Affordable Housing and Sustainable Communities (AHSC) Program.** Currently, AHSC receives a 20% continuous appropriation from the Greenhouse Gas Reduction Fund, providing significant funding for integrated housing and transportation projects across California. AHSC is currently the only meaningful ongoing source of funding for affordable housing in the state. With no new money for affordable housing production proposed in the Governor's revised May budget, protecting AHSC's 20% continuous appropriations is more important than ever, to ensure that affordable housing production does not grind to a halt.

### 2.
