Who is Enterprise

- **Enterprise is a national nonprofit whose mission is to make home and community places of pride, power and belonging.**
- **We support community development organizations on the ground, aggregate and invest capital for impact, advance housing policy at every level of government, and build and manage communities ourselves.**
- **Since 1982, we have invested over \$80 billion and created 1 million homes across all 50 states, the District of Columbia and Puerto Rico.**
- **Own and operate over 13,000 affordable homes in the Mid-Atlantic.**



Program History and Objectives

Origins

FBDI was started by Enterprise's Mid-Atlantic office in 2006, with input from the NYC office based on their transactional work with faith-based projects. Original co-conveners/strategic advisors included:

- East of the River Clergy-Police-Community Partnership
- Georgetown University
- Wesley Seminary

Goals

- Expanding the supply of housing
- Supporting equitable procurement
- Strengthening neighborhood anchor institutions
- Aim to “Build an Enterprise program while nurturing a national movement”.

Why: “Radical Common Sense”

- **Need:** 20% of renters pay more than 50% of income for housing. Approximately 600,000 homeless individuals in the U.S. 13M+ live in food desert. Half of Americans live in a child-care desert.
- **Potential:** Houses of worship own a large amount of real estate.
 - 2019 Urban Institute analysis examined 800 vacant parcels owned by houses of worship in Arlington and Fairfax VA, Montgomery County, MD and Washington, D.C. Estimated that 43,000-109,000 new housing units could be built.
 - Note: Estimates of 100,000 churches closing in the U.S. between 2015-2030. (Dr. Eileen Linder, National Council of Churches of Christ, USA).

- Grants for early pre-development expenses, including Market Studies/Feasibility Analysis

Peer Learning

- Peer learning exchanges for senior clergy: “Iron Sharpens Iron”

FAITH IN HOUSING CHARLOTTE: AN ENTERPRISE FAITH-BASED DEVELOPMENT TECHNICAL ASSISTANCE COHORT

- A series of no-cost training and peer learning sessions designed to help houses of worship understand and navigate the development process to advance their development projects
- Provide funding support (from City of Charlotte) to help houses of worship advance their projects from vision to completion, providing critical housing for low- to moderate- income people
 - Market Study & Feasibility Analysis Grants
 - Pre-Development Grants
 - Access to Enterprise Capital Products
- One-on-one tailored technical assistance (from the City of Charlotte) to faith-based developers to build capacity and help advance their projects through the development process
- Access to a vetted list (bullpen) of key development partners i.e. Architects, Real Estate/land-use Lawyers and Real Estate Developers/Development Consultants
- Online library of FBDI tools and resources to support houses of worship engaged in the cohort

ELIGIBILITY AND PROGRAM REQUIREMENTS

Eligibility and Program Requirements

Applicants must meet all requirements specific to this call for applications

Organizational Eligibility

- **Organization Type** – Applicants may be either:
 - (a) a House of Worship and/or a Faith-Based Organization that owns land/property located within the City of Charlotte and are pursuing development, or contemplating the development, of affordable housing and/or community serving facilities on the real estate the house of worship currently owns in the City of Charlotte
 - (b) a non-profit community development organization (CDO) formally affiliated with a HOW that owns land/property in the City of Charlotte upon which they are pursuing development or contemplating the development of affordable housing and/or community serving facilities on the real estate the organization owns in the City of Charlotte.
- **Geographic Focus** – Applications may only be considered for a FBDI-eligible organization that desires to develop affordable housing and/or community serving facilities on property that they own in the City of Charlotte.
- **Project Type Preference** – Priority will be given to applicants who are pursuing *affordable housing* development.

Eligibility and Program Requirements (cont.)

Applicants must meet all requirements specific to this call for applications

Program Terms

- **Program Period of Performance** – The training portion of the FBDI Technical Assistance Cohort will occur over a seven to eight month period beginning October 2025. TA cohort members must commit to attending all sessions.
- **Cohort participants are expected to stay engaged** with Enterprise and the City of Charlotte, NC for the period of time that they are pursuing their development projects in order to access the funding support
- **Reporting** – Participants will be required to provide information that supports Enterprise's evaluation of the impact of the FBDI Technical Assistance Cohort. The bulk of this participation will take the format of training evaluations, post-training surveys, etc. Every effort will be made to minimize the time and effort required by participants.

- Name and email addresses Identification of clergy leader and staff that will attend each session
- Ways that your organization is culturally responsive to the communities it serves

Selection Criteria / Evaluation

Applications will be reviewed by Enterprise staff. Priority will be given to applicants who are pursuing *affordable housing* development. Each application will be evaluated on the following criteria:

- Organizational capacity to pursue and affordable housing and or community serving facility development project including staff capacity to successfully complete training and dedicate time to working with TA provider/development consultant **(40 points)**
- Organizational Narrative **(35 points)**
- Completed FBDI Enterprise Organizational Assessment **(20 points)**
- Property/Land Ownership and/or Site Control **(5 points)**

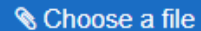

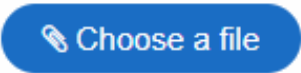
