

- Leading, AA- rated CDFI



Enterprise Resilience Academy

- 8 Resilience Academies (Southeast, Gulf Coast, New York/NJ, West Coast, Rocky Mountain, Midwest, Mid-Atlantic, Housing Partnership Network)
- 140 affordable housing owner/operator cohort members
- 25 states represented
- 40 academy sessions
- \$525,000 in grants to cohort members
- Southwest Tribal Climate Resilience Academy will start later this month



Findings from Resilience Academy Evalutation

- The areas that saw the largest increases in average capability were accessing resilience-related TA or connecting with consultants, assessing the climate risk of respondents' portfolios, and preparing to navigate insurance regulations for affordable housing.
- The areas where respondents reported the most capacity six months after the Academies are assessing the social risk of residents and assessing the climate risk of their portfolio.
- Six months after the Academies, participants still report needs related to locating and obtaining financial resources to implement resilience strategies.
