Codsadayaasha u qalma

1) Yaa lagu dhiirigelinayaa inuu codsado?

- Bixiyeyaal ama bixiyeyaasha xarunta ku salaysan ee hadda shatiga haysta ee doonaya inay noqdaan xarumo daryeel ilmo oo shati leh (aan guri ku salaysnayn).
- Bixiyeyaasha xanaanada caruurta waxay iskaashi la sameeyeen hay'ado guri oo la awoodi karo
- Noocyada ururka ee xaqa u leh waxaa ka mid ah:
 - ◇ Xarumaha daryeelka carruurta, ururada maaraynta hantida aan faa'iido doonka ahayn, horumarinta guryaha la awoodi karo (macaash doonka iyo kuwa aan faa'iido doonka ahayn), qabaa'ilka la aqoonsan yahay, kulliyadaha bulshada iyo farsamada, iyo hay'adaha diinta ku xiran ayaa sidoo kale la dhiirigeliyay.

2) Ma jiraan shuruudo uu codsaduhu u baahan yahay inuu buuxiyo?

- Codsadayaashu waxay u baahan yihiin inay haystaan ama ay damcaan inay shati haystaan oo si wanaagsan u maraan Waaxda Carruurta, Dhallinyarada iyo Qoysaska ee Gobolka WA (DCYF).
- Xarumaha xanaanada caruurta waa inay ahaadaan ka qaybqaatayaal firfircoon ama ay ku talo jiraan inay noqdaan ka qaybqaatayaal firfircoon oo si wanaagsan ula taagan Early Achievers, ama barnaamij aqoonsi la mid ah oo tilmaamaya u hogaansanaanta heerarka tayada sare leh.
- Waa in uu leeyahay shatiga ganacsiga Gobolka WA si uu u bixiyo adeegyada waxbarashada hore.

3) Haddii mashruucu la wadaago guri la awoodi karo ama ururka horumarinta bulshada, yaa buuxinaya codsiga?

- Ururka guryaha la awoodi karo/ururka horumarinta bulshada ama bixiyaha xanaanada caruurta ayaa buuxin kara codsiga. Fadlan la soco in ku kasta oo ah codsada koowaad uu noqon doono qaataha deeqda koowaad haddii la bixiyo. Dhammaan wada-hawlgalayaasha mashruuca waa in lagu qoraa codsiga.

4) Waa maxay noocyada mashaariicda ee xaq u leh maalgelinta?

- Maalgelin ayaa loo heli karaa si loogu taageero dhismaha xarumaha cusub ee xanaanada carruurta ama ballaarinta xarumaha daryeelka ilmaha ee jira. Tan waxaa ku jira bixiyeyaasha waxbarashada hore ee xarun-ku-saleysan, kuwa aan guriga ku saleysneyn. Maalgelinta waxaa

sida caadiga ah loo heli karaa: Kharashyada horu marinta, kharashyada dhismaha iyo dayactirka weyn/yar yar, iyo Helitaanka .
